Müller-Guttenbrunn Group strengthens management structure in Romania.

After the Müller-Guttenbrunn opened the completely new headquarters and branch of S.C. REMAT M.G. S.A. in Frumuseni near Arad early October 2012, the new site specialized itself on the processing of non-ferrous metals, cable recycling as well as on Wastes of Electric and Electronic Equipment (WEEE).

Since the Müller-Guttenbrunn Group - with their base in Austria and further subsidiaries in the Czech Republic, Hungary and in Romania - withdrew from their activities in Bulgaria, the MG Group decided to further develop the E-Waste activities, focusing especially on the recycling depth, particularly on the Frumseni site near Arad. The volumes of E-Waste will certainly grow over the next few years following the implementation of the new EU WEEE directive and furthermore the European Standardization Institute for Electronics, Cenelec, is developing a unified treatment standard for the processing of E-Waste.



Plans are ready to expand the processing technology on the site of Frumuseni to improve the recycling depth of the installation.

The planned investments will add non-ferrous sorting equipment for recycling electronic waste and the installation will have a capacity to process some 10 tons of E-Waste per hour.

"There is a regular exchange of materials between the specialized sites of the group and the current recycling depth of the Müller-Guttenbrunn Group is already capable to match the recycling targets set by the EU WEEE Directive for 2018" adds Mag. Christian Müller-Guttenbrunn CEO of the MG Group. The investments are planned to prepare the Frumuseni for the implementation of the Cenelec Treatment Standard.

Furthermore the Group announced that the management of both companies of the Müller-

Guttenbrunn Group in Romania - Remat MG with the base in Arad and Silnef MG headquartered in Brasov - will be strengthened with management staff. Mr. Tom-Henry Mettke has been added to the management team of Silnef MG in Brasov and the former manager of MG Recycling in Bulgaria - Mr. Mischa Gromen will be added to the management team in Arad.
